**Area of Cooperation**

The Area of collaboration includes, based on mutual equality and reciprocity of benefits, programs offered at either universities and proposed by either as feasible and contributory to the fostering and development of the cooperative relationship between all universities in this memorandum.

**Methods of Cooperation**

All parties agree to encourage and promote the following academic and scholarly activities:

- 1) Development of join course and academic programs.
- 2) Exchange of students.
- 3) Exchange of faculty and staff members.
- 4) Exchange of information including the exchange of library materials and research.
- 5) Join in the management and publication of the journal.
- 6) Join research, lectures, conferences, and workshops.
- 7) Join equipment, facilities and resources usage.

The detail of all activites, including new suggestions that are not reflected in this memorandum, may be proposed and implemented on the basis of understandings to be signed by both institutions. All

financial arrangements involved in the implementation of this Memorandum will be established in the development of the individual initiatives and will be mutually agreed upon by individual party.

This Memorandum of Understanding may be amended at any time by mutual consent and will be effective for a periode of five years commencing from the date of signature after which, it will automatically be extended for another five years unless one of the intitutions seeks to terminate it through by written notice one years prior to expiry.

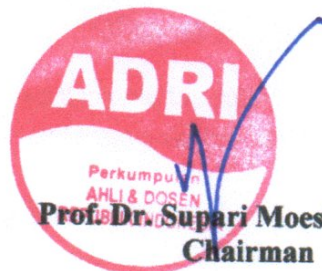
